

DATE	GNMP ROUND 2 MATCH ACTIVITIES
Monday 2 October	<b>Round 1 Results Published</b> <ul style="list-style-type: none"> <li>Match results at 10am</li> <li>Unmatched candidates are emailed the details of health services with unmatched places.</li> </ul>
Monday 2 – Tuesday 3 October	<b>PMCV Admin</b> <ul style="list-style-type: none"> <li>PMCV complete the transfer of unmatched candidate &amp; health service information to the Round 2 Match. This includes unmatched candidates' referee reports &amp; video interviews.</li> <li>Candidates will receive two emails, one indicating withdrawal from Round 1 Match, the second email confirming their registration has successfully transferred to Round 2.</li> <li>Candidates' Round 2 health service preferences will be blank.</li> </ul>
Wednesday 4, 10am – Friday 6 October 5pm	<b>Round 2-Candidates Add preferences or Withdraw</b> <ul style="list-style-type: none"> <li>Candidates enter desired health service preferences from the emailed list. <ul style="list-style-type: none"> <li>Should a candidate preference a Health Service which was not in their Round 1 preferences, they must send an application to the new Health Service. E.g. send cover letter/CV/new Candidate ID.</li> </ul> </li> <li>Candidates can withdraw and therefore not be considered for a graduate place e.g., if they have failed a subject or have deferred placements</li> </ul>
Friday 6 October, 5pm	<ul style="list-style-type: none"> <li>Final day for candidates to add health service preferences.</li> </ul> <p>NOTE: Candidates failing to enter any preferences by this date will not be included in the Round 2 Match.</p>
Monday – Thursday 12 October	<b>PMCV Admin</b> <ul style="list-style-type: none"> <li>Finalise candidate approvals into the Round 2 match</li> <li>Eligibility confirmation</li> </ul>
Friday 13 – Friday 20 October	<b>Health Services' Selection Process</b> <ul style="list-style-type: none"> <li>Health services assess new and existing direct applications on their candidate list.</li> </ul>
Monday 23 – Tuesday 24 October, 5pm	<b>Health Service Rankings Submission &amp; Confirmation of Positions</b> <ul style="list-style-type: none"> <li>Health Services enter candidate rankings and confirm final number of places on offer for the Round 2 Match.</li> </ul>
Wednesday 25 – Thursday 26 October	<b>Allocation and Placement Process</b> <ul style="list-style-type: none"> <li>PMCV run the matching algorithm for unmatched positions &amp; candidates</li> </ul>
Friday 27 October 10am	<b>Round 2 Match Results Published</b> <ul style="list-style-type: none"> <li>Candidates receive an email of the Round 2 Match outcome and / or can log in to see their result.</li> </ul> <p><b>NB: Candidates who decline their Round 2 matched offer are NOT eligible to apply for other positions with any other health service.</b></p>
